California Considers Breeder Registration & Fee--Letters Needed! Hearing Now Set for April 22, 2002

Dog fanciers in California are facing additional burdens as the state legislature considers new requirements for breeders and pet dealers. Introduced by Senator Jack O'Connell and amended most recently on April 16th, SB1373 requires breeders and pet dealers to register with a local animal control agency and pay a fee before the sale of each animal. Breeders and pet dealers are further required to list their "registration fee receipt number" in any advertisement associated with the sale of that animal. Lastly, breeders and pet dealers must ensure that the dog or cat has been microchipped and the owner's identification registered in a local or national database.

SB1373 was referred to the Senate Committee on Business and Professions. A hearing has been set for Monday, April 22nd. Fanciers may recall that SB236, a similar bill also introduced by Senator O'Connell, stalled in committee in 2001 after facing tremendous opposition by dog owners.

This state-mandated program will be extremely costly, time-consuming and ineffectual for local animal control authorities to enforce. It also places undue burden on responsible breeders as well as buyers. Disreputable breeders will ignore the new regulations just as they shirk current animal control laws. Those conscientious breeders who do comply with the new regulations will be forced to pass on these expenses to the new owner, and thereby do a disservice to California consumers.

The AKC promotes responsible ownership and encourages dog owners to properly identify their pets. However, the form of identification-whether by collar, tattoo or microchip-should be made by the owner, not the government. Finally, the decision about whether to enroll with a pet registry should be left to the owner, not dictated by government.

SB 1373 is overly intrusive, cost-prohibitive to enforce, and discourages personal responsibility. It places too many burdens on responsible breeders and will lead to increased costs for new owners. It will also create a sea of bureaucracy and paperwork for local animal controls that are already understaffed and underfunded. SB1373 must not be allowed to pass.

What You Can Do:

· Write a letter of opposition to the committee:

The Animal Council, an animal federation in California, offers the following information: A committee consultant will prepare a written analysis including existing law, arguments pro and con and listing support and opposition, naming organizations and usually a general reference to individual opposition. IT IS VERY IMPORTANT THAT WE HAVE A SUBSTANTIAL NUMBER OF ORGANIZATIONS LISTED AS OPPOSITION. Fax is usually the safest method and assures us of building a good-sized stack of paper for the opposition. AKC clubs in California should act now!
