DELEGATE: - Lois Wilson (2 Year Term)

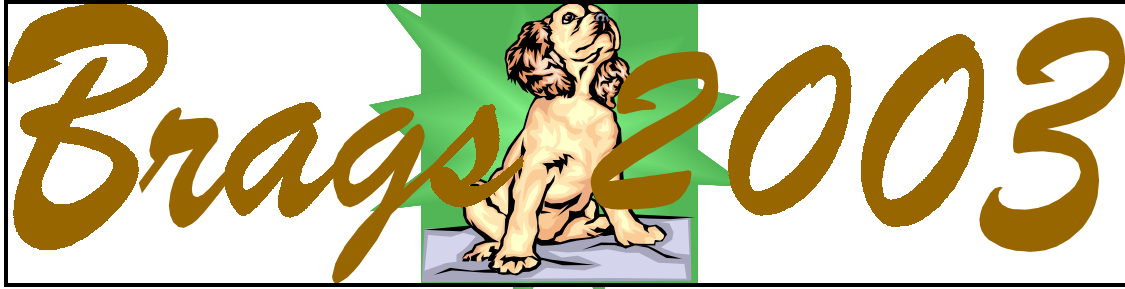
Board Members who were elected for 2 year terms last year and who will be eligible for re-elections in 2004 are:
