Acting Responsibly

The following is an excerpt from the "Flatiron Press" - Littleton, Colorado.

Acting Responsibly:

Sometimes I think we lose sight of the real purpose of our association with dogs and the dog world. Many people in their rush to buy, show and breed never really learn the true meaning of their responsibility to dogs. We become so bound up in the political moves of the dog world, in what dogs can do for us, that we forget that we are actually supposed to be doing something for dogs.

Whether or not you belong to a club, keep in mind your personal responsibility to your breed. This means giving the very best home to your own dog and using your influence on others to do the same. If you are contemplating breeding, don't, unless you feel your dog will make a positive contribution to the breed. All too often people, in their effort to become recognized, feel that if they breed this will somehow establish them as a breeder and bring them prestige. Breeding does not make a breeder.

Responsibility Of The Club:

The primary function of the club are protection of dogs and education of the membership and general public. The all-breed club attempts to educate its members in all aspects of dogs and to make them well-rounded members of the dog world. The breed club has its responsibility in education of its members and non-members in the breed, but should not lose sight of the fact that some members of breed clubs are lacking in all-around education. Therefore, this need should not be ignored in planning club programs.

Responsibility Of The Board:

The Board's responsibility is to further the objectives of the club as outlined in the by-laws. In striving for this goal, the board must not lose sight of the needs and desires of the membership. Since these needs are continually evolving and changing, it is especially important that board members avoid isolating themselves. They must not lose sight of the fact that they are the elected representatives of the membership and, therefore, answerable to the membership. Since the membership supports the club from dues and other fundraising efforts, they should have a voice in how their money is used.

Responsibilities Of The Members:

The members work for the club. What is the point of club membership if it is not to make a contribution to the club and to the world of dogs. When you contemplate joining a club, it should be with the realization that you are going to work. All too often people join a club for prestige of membership. Usually, these people are not workers but are looking for their own advancement through office. In our own all-breed club, no person is considered for board membership without having proved themselves as a hard worker, someone with good ideas and one who will have a positive influence on the membership. Consequently, our board and members are extremely productive. The membership should give strong support to the board as long as the board acts in the best interest of the members.

Breed clubs can be very productive, even with their geographical spread, if they have the leadership with the vision to understand how this can work for them.

If you are currently a member of any club, ask yourself what you can do for that club. Possibly start a program in your area that involves club members and educates both members and non-members.

If you are currently serving on a board, ask yourself what contribution you are making to that club and to the world of dogs. If you are not contributing, why are you serving?

If you are asked to serve on a board, don't accept unless you can make a positive contribution.

There are always programs to be started and worked on in clubs. Those that are creative and productive may initiate them but they need the assistance of helpers and contributors. Make a contribution to the world of dogs by recognizing your abilities and acting accordingly. Don't accept a job you cannot do which can only result in damage to your club.

If you act responsibly and do the best you can, at the end of the year, you should look back and be able to cite at least one contribution you have made to the world of dogs, and that's what it's all about.

AKC/EUKANUBA NATIONAL CHAMPIONSHIP LAUNCHES COMMEMORATIVE POSTER CONTEST

-- AKC Encourages Artist Submissions that Depict "The Wonderful World of Purebred Dogs" --

New York, NY (April 23, 2008) - The American Kennel Club and Eukanuba are pleased to launch the annual commemorative poster competition in which artists are encouraged to submit an original two-dimensional painting or drawing celebrating the theme: "The Wonderful World of Purebred Dogs." The poster will commemorate the eighth annual AKC/Eukanuba National Championship where 2,500 top dogs from 50 states and 52 countries compete for \$225,000 and one of the biggest honors in the dog world.

The theme of the artwork may incorporate a variety of images depicting the best in purebred dogs including, but not limited to: illustrations of human/canine bond, AKC events, colorful expressions of the intensity of the AKC/Eukanuba National Championship, images of people and purebreds in action, past winners and the event's setting. In conjunction with the theme, submissions should include multiple breeds.

The show is scheduled to be held in Long Beach, California on December 13-14, 2008 and will be nationally televised on Animal Planet. For inspiration and more information about the AKC/Eukanuba National Championship or AKC events, please visit http://www.akc.org.

The deadline for submissions is October 10, 2008 for online entries and October 13, 2008 for postmarked mail-in entries. An expert panel will select ten initial finalists, with the grand prize winner chosen from among those finalists.

The grand prize winner will receive \$1,000 and a four-day/three-night trip for two to the AKC/Eukanuba National Championship in Long Beach, California December 13-14 (including airfare and hotel). The winning artwork will be used in a commemorative poster that will be sold at the event as well as on the AKC Web site. Proceeds will be donated to Take the Lead, a 501(c)3 not-for-profit organization that provides direct services, support and care for people in the sport of purebred dogs who suffer the devastation of a life-threatening or terminal illness.

"We are pleased to again welcome submissions for the AKC/Eukanuba National Championship poster contest," said Ron Menaker, AKC Chairman. "Each year, we receive many outstanding entries that reflect the beauty of purebred dogs and the excitement of the event. As an added benefit, this competition also raises much needed money for Take the Lead, an organization that lies close to the heart of many involved in the sport."

Eukanuba's Jason Taylor said that this competition is a natural fit with the AKC/Eukanuba National Championship because dogs have been depicted in art over the course of centuries. "It takes an artist to capture the excitement and energy of dogs and the artwork we receive represents the spirit of the event very well."
